4.Considering the facts and circumstances of the case and the submissions made by the petitioner, the condition already imposed on the petitioner is modified to the effect that the petitioner is directed to report before the Dindigul North Police Station, daily at 10.00 a.m. and 05.00 p.m. until further orders.
