This petition is filed to extend the time granted to the petitioner in Crl.OP(MD)No.11652 of 2016, dated 14.07.2016.

This Court, by order dated 14.07.2016 made in Crl.OP(MD)No.11652 of 2016 granted anticipatory bail to the petitioner and directed the petitioner to appear before the concerned Magistrate, within a period of 15 days from the date on which the order copy was made ready. However, the petitioner did not comply with conditions, within the time prescribed by this Court. Hence, she has approached this Court with the present petition for extension of time.



3. The learned counsel for the petitioner contended that the petitioner could not produce the sureties within the time prescribed by this Court and hence, he prays for extension of time.

4. Heard the learned Government Advocate(Crl.Side).

5. Considering the reasons stated in the affidavit filed in support of this petition, this petition is ordered and the time for execution of sureties is extended till 22.08.2016. No further time will be given.
