The learned Government Advocate (Crl.Side) submitted that the petitioner is complying with the condition regularly.

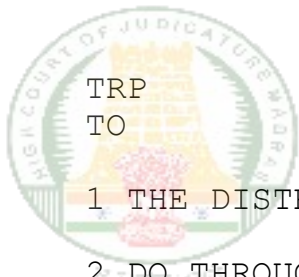
2. Considering the above submission, the condition already imposed by this Court is modified to the effect that the petitioner shall appear before the respondent Police as and when required for interrogation.
