This petition is filed to extend the time granted to the petitioner in Crl.O.P(MD)No.12563 of 2016, dated 22.07.2016.

2 This Court, by order dated 22.07.2016, made in Crl.O.P.(MD) No.12563 of 2016, granted anticipatory bail to the petitioner and directed the petitioner to appear before the concerned Magistrate, within a period of 15 days from the date on which the order copy was made ready. However, the petitioner did not comply with conditions, within the time prescribed by this Court. Hence, he has approached this Court with the present petition for extension of time.

3 The learned counsel for the petitioner contended that the petitioner could not produce the sureties within the time prescribed by this Court and hence, he prays for extension of time.



5 Considering the reasons stated in the affidavit filed in support of this petition, this petition is ordered and the petitioner shall execute the sureties within a period of one week from the date of receipt of a copy of this order.
