Heard both sides.

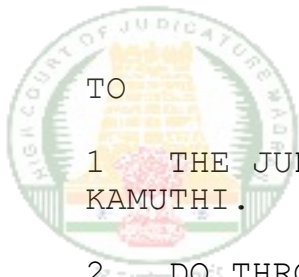
2. The learned Government Advocate(Crl.Side)submitted that the petitioner is complying with the condition regularly.
