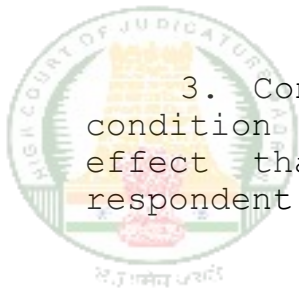
COMMON PRAYER IN CRL MP(MD) Nos.7654/2016 7655,7656 and 7657 of 2016
