Heard both sides.

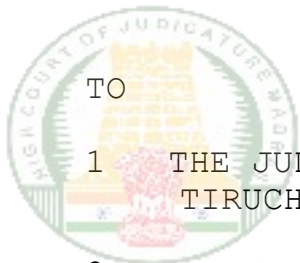
2 The learned Government Advocate(Crl.side) submitted that the petitioners are complying with the condition regularly.
