Prayer in CRL MP(MD)No. 7777/2016 :

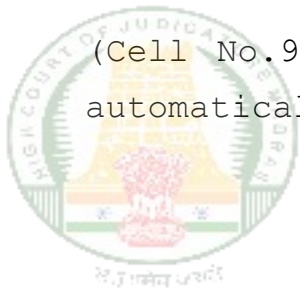
