Records awaited.

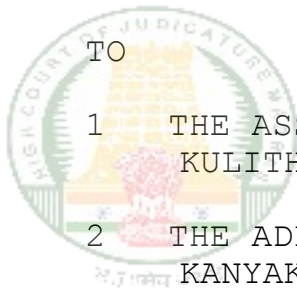
The interim order of suspension already granted by this Court on 05.10.2016, is made absolute.
