Prayer in CRL OP(MD). 22696/ 2015 :

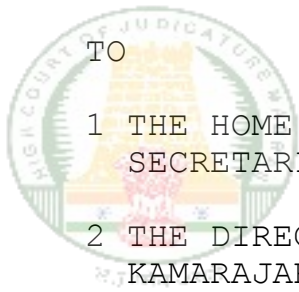
To withdraw the investigation pending in Cr. No.54 of 2014 on the file of the 4th respondent and enstruct the same to the CBCID or any other independent agency.
