The learned counsel for the petitioner and the learned counsel for the respondents are present.

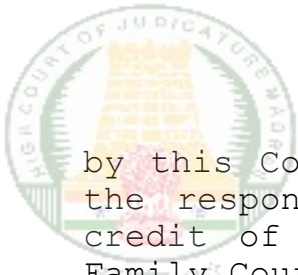
2. Heard both sides.
