For Respondents : Mrs.S.Prabha, G.A.(Crl.side)

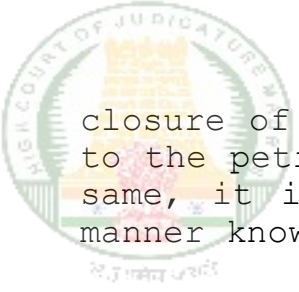
ORDER

It is an application, seeking a direction to the 3rd respondent to register a case based on the complaint of the petitioner.

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.side) for the respondents.

3.According to the learned Government Advocate (Crl.side) petition enquiry is pending before the 3rd respondent Police.

4.In view of the above submission, the 3rd respondent is directed to expedite the enquiry and complete the same within a period of one month from the date of receipt of a copy of this order. During the course of enquiry, if any cognizable offence is made out, the 3rd respondent Police shall take action in accordance with law laid down by the Hon'ble Apex Court in **Lalitha Kumari Vs. Government of U.P. & Others (2013(4) Crimes 243 (SC))**. In case of



closure of the complaint, a copy of the closure report be furnished to the petitioner within a week of such closure. On receipt of the same, it is open to the petitioner to work out the remedy in the manner known to law.

5. With the above direction, the Criminal Original Petition is disposed of.
