(iii) That, permission is accorded to compound the offence;

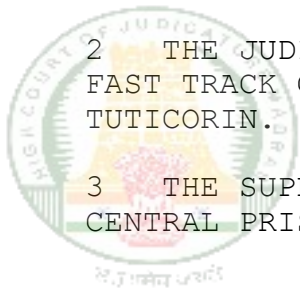
