2. Based on petitioner's complaint, Central Crime Branch, Madurai City Police, registered a case in Crime No.103 of 2014, under Sections 419, 420, 465, 468, 471 r/w 120(b) I.P.C., on 22.09.2014.

3. The learned counsel for the petitioner submits that the investigation is going on at snail's space, it is required to be speeded up.

4. The learned Government Advocate (Criminal Side) submits <https://hds.mca.gov.in/hdservices> is a peculiar case. It has got lot of complications. It involves collection of documentary evidence from Bank and other places. Further, report of Handwriting Expert is also awaited.
