Act, registered by Vembakkottai Police Station, seeks a direction to the learned Sessions Judge, P.C.R.Court, Virudhunagar, to consider his bail petition on the date of his surrender.

**2.** Heard the learned counsel for the petitioner and the learned Government Advocate (Criminal side) for the respondent.

**3.** The petitioner is accused of having committed offences under S.C. / S.T. Act. As per Section 18 of the Act, advance bail petition under Section 438 Cr.P.C., will not lie.
