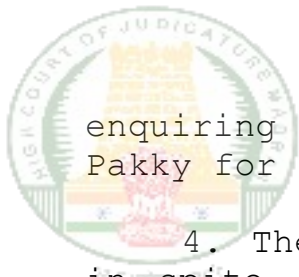

enquiring the matter. A police notice has been issued to Abdul Pakky for enquiry on 17.07.2016.

4. The learned Government Advocate (Crl.side) submitted that in spite of the notice, the said petitioner Abdul Pakky is not attend the enquiry.

5. The learned counsel for the petitioner submitted that the petitioner will attend the enquiry on 27.07.2016.

In the circumstances, the petitioner viz., M.Abdul Pakky shall appear before the third respondent viz., the Sub Inspector of Police, S.P.Pattinam Police Station, Ramanathapuram District, for enquiry with regard to the complaint given by him, on 27.07.2016 at 10.30 a.m. and thereafter, the third respondent will proceed with the enquiry in accordance with law.

Accordingly, this Criminal Original Petition is disposed of.
