ORDER

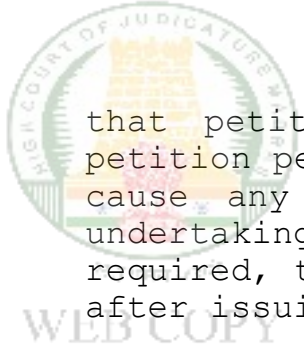
This Criminal Original Petition has been filed by the petitioners seeking a direction to the 3rd respondent not to harass the petitioners except under due process of law.

3.The learned counsel for the petitioners would submit that the respondent Police frequently called the petitioners to the Police Station and harassed them under the guise of enquiry.

4.The learned Government Advocate (Criminal Side) submitted



that petitioners were called only for enquiry in respect of a petition pending against them and that the respondent Police did not cause any harassment to the petitioners. However, she gave an undertaking that if at all the presence of the petitioners is required, the respondent would call the petitioners for enquiry only after issuing summons giving specific date, time and place.

5. Recording the above undertaking given by the learned Government Advocate, this Criminal Original Petition is closed.
