PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the alleged offences under Sections 468, 471, 420, 408, 409 read with 109 IPC and Section 13(2) read with 13(1)(c) (d) of Prevention of Corruption Act, in C.C.No.5 of 2005, on the file of the learned Chief Judicial Magistrate, Sivaganga, seeks anticipatory bail.

2. It is submitted by the learned counsel for the petitioner that due to the absence of the petitioner, non-bailable warrant was issued against the petitioner on 02.08.2016 by the learned Chief Judicial Magistrate, Sivaganga.

3. The learned Government Advocate (Crl. Side) submitted that due to absence of the petitioner for one hearing, non-bailable warrant was issued against the petitioner and the petitioner may be directed to approach the Court for recalling the warrant.

4. Considering the fact that non-bailable warrant was issued against the petitioner for his absence, there shall be a direction to the petitioner to surrender before the learned Chief Judicial Magistrate, Sivaganga, and to file a petition for recalling the warrant and the learned Chief Judicial Magistrate, Sivaganga, is directed to consider the same on the same day and pass orders on merits in accordance with law.



5. Accordingly, this Criminal Original Petition is disposed of.
