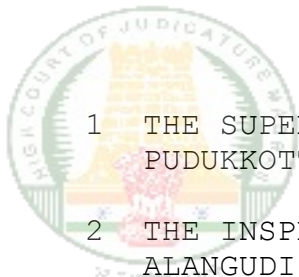

COMMON ORDER

The petitions filed under Section 482 Cr.P.C., directing the respondents to register a case based on the complaint given by the petitioners and to conduct fair and impartial investigation in accordance with law within the period stipulated by this Court.

2.The learned Government Advocate (Crl.side) appearing for the respondent Police on instruction would submit that the complaint has been received by the respondent Police and the same will be enquired into and if *any prima facie case* is made out, the said complaint would be registered and the investigation would be completed.

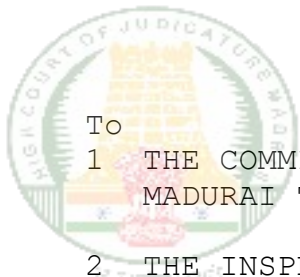
3.Considering the submissions made on either side, this Court is inclined to direct the respective Police to enquire into the veracity of the complaint in adherence to the principles and directions laid down by the Honourable Apex Court in the case of *Lalita Kumari -Vs-Government of U.P and others* reported in 2013(4) Crimes 243 (SC) and complete the same within a period of one month from the date of receipt of a copy of this order. In the event of the respondent Police finding any *prima facie* case in the complaint of the petitioners, they shall register a case within a period of one week thereafter.

4.In case of closure of complaint, the respective respondent Police is directed to send a copy of the closure report to the petitioners within a period of one week from the date of closure. On receipt of the same, it is open to the petitioners either to make a private complaint or recourse to any other provisions of law. The Criminal Original petitions are disposed of accordingly.
