ORDER

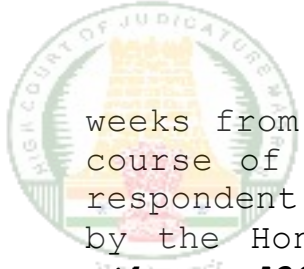
It is an application seeking a direction to the 2nd respondent to register a case against the accused based on the complaint dated 15.08.2016 lodged by the petitioner.

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondents.

3.According to the learned Government Advocate (Crl. Side), petition enquiry is pending.

4.There is no contention that the nature of the complaint requires immediate registration of the case.

weeks from the date of receipt of a copy of this order. During the course of enquiry, if any cognizable offence is made out, the 2nd respondent shall take action in accordance with the law laid down by the Hon'ble Apex Court in **Lalitha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC)]**. In case of closure of the complaint, a copy of the closure report be furnished to the petitioner within a week of such closure. On receipt of the same, it is open to the petitioner to work out her remedy in the manner known to law.

6. With the above direction, this Criminal Original Petition is disposed of.
