PRAYER: Review Application filed under Order 47, Rules 1 and 2 r/w. Section 114 of Civil Procedure Code, to review the order dated 08.02.2016 passed in W.P.No.2682 of 2016.

Prayer in WP(MD). 2682/ 2016 :

Writ Petition filed under Article 226 of the Constitution of India, for issuance of a Writ of Mandamus, directing the 1st respondent to pay the petitioner Rs.6,97,093/- towards Gratuity and Rs.8,118/- towards Leave Salary and also arrears of wages for the period from 01.09.13 to 31.01.15 payable pursuant new wage settlement, together with 18% interest per annum and further directing the respondents to pay him Rs.2,87,794/- towards the Pension Commutation amount and arrears of pension for the period from 01.02.15 by revising his pension together with 18% interest per annum within a time frame as may be fixed.

**ORDER**
