4.The learned Government Advocate appearing for the respondents, on instructions, would submit that the third respondent would consider the representation of the petitioner dated 14.07.2016 and pass appropriate orders on merits.

5.In view of the above submission made by the learned Government Advocate, this Criminal Original Petition is disposed of with a direction to the third respondent to consider the representation of the petitioner, dated 14.07.2016 and pass appropriate orders on merits and in accordance with law forthwith.
