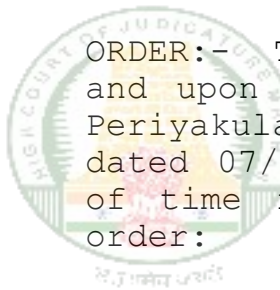
Prayer in A.S.No. 16 of 2016 :-
