It is an application seeking a direction to the respondents 2 and 3 not to interfere in the civil dispute.

3.The learned counsel for the petitioner would submit that the petitioner purchased a house property on 24.03.2016 and despite the title is in his favour, the 2nd and 3rd respondents threatened him to vacate the property and hence, he has come up with this petition.

However, he gave an undertaking that if at all the presence of the petitioner is required, the respondents would call him for enquiry only on issuing summons giving specific date, time and place and that the petition enquiry would be completed within a period of one week.
