PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

Petitioner / A4 prays for grant of anticipatory bail under Section 438 of Cr.P.C. for offences punishable under Sections 364(A) @ 364(A), 147,323,354 and 120(b) of IPC in Crime No.310/2016 on the file of respondent police.

2. The defacto complainant has alleged that making a demand of repayment of money, the accused persons had taken a daughter of the defacto complainant and dropped her nearby bus stand.

3. The learned counsel for the petitioner submits that the petitioner is innocent and he has not committed any offence as alleged by the prosecution and his name has been falsely implicated in this case.

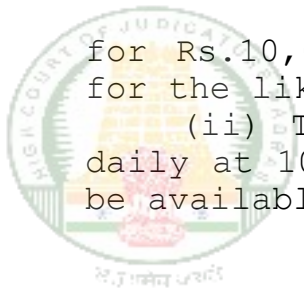
4. Learned Government Advocate (Crl. Side) submits that the investigation is pending.

5. On consideration of the facts and circumstances of the case and the submissions made, this Court is of the view that the petitioner can be granted the relief prayed for and accordingly;

(a) In the event of arrest by or on appearance before the respondent police;

(b) In the event of appearance before the learned Judicial Magistrate, Melur; within 15 days from the date of receipt of copy of the order;

(i) Petitioner shall be enlarged on bail on executing a bond



for Rs.10,000/- (Rupees ten thousand only) with two sureties each for the like sum to his satisfaction;

(ii) The petitioner shall report before the respondent police daily at 10.30 a.m for a period of two weeks and thereafter, shall be available for interrogation as and when required.
