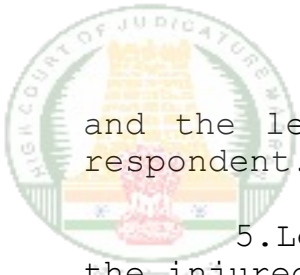
This petitioners seek a direction to the learned I-Additional District and Sessions Judge, (PCR Court), Thanjavur, to consider the bail application filed by the petitioners on the same day of their surrender in Crime No.198 of 2016 on the file of the respondent police.

2. The petitioners are accused for the offences punishable under Sections 341, 294(b) and 324 IPC read with Section 3(1)(r) (s), 3(2)(Va) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Amendment Ordinance Act.

3. Learned counsel for the petitioners would submit that the petitioners are innocent and they have been falsely implicated in the case due to previous motive and that in view of the specific bar under Section 18 of the said Act, the petitioners cannot move any anticipatory bail application and therefore, the petitioners have come up with this petition.
