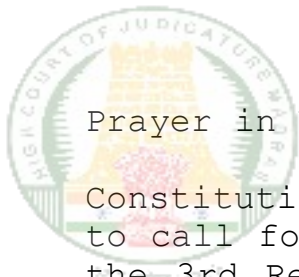

On hearing learned counsel for parties, with consent, the impugned order is modified to the extent that the monthly payment will stand increased from Rs.2,00,000/- (Rupees Two Lakhs only) to Rs.5,00,000/- (Rupees Five Lakhs only) per month commencing from November, 2016.
