ORDER : The Court Made the following order :-

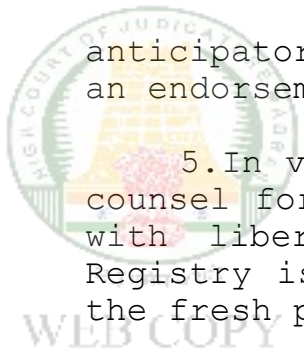
This is an application filed by the petitioners for anticipatory bail at petition enquiry stage.

2.Heard the learned counsel appearing for the petitioner and the learned Government Advocate(Crl. Side) appearing for the respondent/State.

3.The learned Government Advocate(Crl. Side) would submit that FIR was registered in Crime No.232 of 2016, dated 10.12.2016 for the offences under Sections 147, 420, 294(b) and 506(i) IPC against the petitioner herein and four others.
