ORDER

It is an application seeking a direction to first respondent to direct the third respondent not to harass the petitioner and his family members under the guise of enquiry based on the false complaint given by Palaniyandi and Palanichamy.

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondents.

3.The learned counsel for the petitioner would submit that the respondent Police frequently called the petitioner to the Police Station and harassed him and his family members under the guise of enquiry in respect of a civil dispute.

4.The learned Government Advocate (Criminal Side) submitted that petitioner was called only for enquiry in respect of a petition pending against him on the complaint given by one Palaniyandi and Palanichamy and not to decide the civil rights of the parties in the Police Station and that the respondent Police did not cause any harassment to the petitioner. However, he gave an undertaking that if at all the presence of the petitioner is required, the respondent would call the petitioner for enquiry only after issuing summons giving specific date, time and place.



5. Recording the above undertaking given by the learned Government Advocate, this Criminal Original Petition is closed.
