Along with suit, the respondents also filed I.A.No.683 of 2015 for appointment of an Advocate Commissioner to measure the property. The said application was ordered and Advocate Commissioner was appointed. Against that order, the petitioner filed C.R.P.No.1677 of 2015. Now, the petitioner has come out with the present Tr.C.M.P on the ground that pending C.R.P, prayed for stay of the proceedings and transfer the suit from the file of the District Munsif, Thuraiyur to any other Munsif Court within the jurisdiction of the Principal District Court, Trichy.
