PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

Petitioner, who was arrested on 31.07.2016 for offences punishable under Sections 302 @ 147, 148, 120(b) and 302 of I.P.C, in Cr.No.350 of 2016 on the file of respondent police, seeks bail.

2.The allegation against the petitioner is that he caught hold of the deceased facilitating the attack on him by A-1.

3.Learned counsel for the petitioner submits that the petitioner is an innocent and he never involved in the offence.

4.Heard the learned Government Advocate (Crl.Side) appearing for the respondent.

5.Considering the facts and circumstances of the case, this Court is inclined to release the petitioner on bail. Accordingly, the petitioner is ordered to be released on bail on his executing a bond of Rs.10,000/- (Rupees ten thousand only) with two sureties each for the like sum to the satisfaction of learned



Judicial Magistrate, Vadipattai and on condition that the petitioner shall stay at Palani and appear before Palani Town Police Station daily at 10.00 a.m., for a period of one month.
