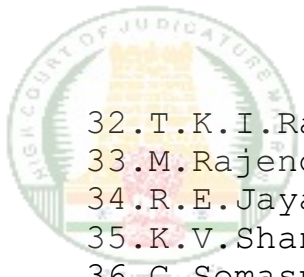

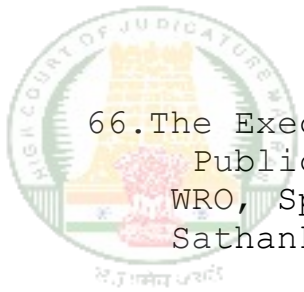

Ms. NO. 162 Finance (Paycell) Department dated 13.04.1998 to the petitioners also by granting Ordinary Grade Rs. 4000-100-6000 and Selection Grade Rs. 5000-150-8000 and Special Grade Rs. 5500-175-9000 according to their total service rendered within a specified time frame that may be fixed by this Court.
