PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

Petitioner/A-3, who was arrested on 26.08.2016 for offences punishable under Sections 120(b) r/w 302 of IPC in Cr.No.1480 of 2010 on the file of respondent police, seeks bail.

2. Learned counsel for the petitioner submits that the petitioner was issued with non-bailable warrant for his non-appearance before the trial court for the only one hearing I.e on 08.08.2016.

3. Learned Government Advocate (Crl.Side) submits that this is a case of jumped out bail. For his non-appearance before the trial court, the petitioner was issued with NBW and on execution of NBW, he is in custody from 26.08.2016.

4. Considering the facts and circumstances of the case and the fact that the petitioner was absent before the trial court for only one hearing, this Court is inclined to release the petitioner on bail. Accordingly, the petitioner is ordered to be released on bail on his executing a bond in a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties each for the like sum to the satisfaction of learned Judicial Magistrate, No.2, Dindigul and on condition that the petitioner shall report before the trial Court daily at 10.30 a.m until further orders.
