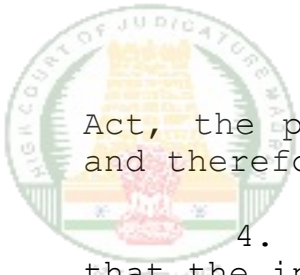

O R D E R

The Criminal Original Petition has been filed for a direction to the learned II Additional District and Sessions Judge cum (P.C.R. Court), Tirunelveli to consider and dispose of the bail application filed by the petitioners in Crime No.139 of 2013 on the file of the respondent herein, on the same day of their surrender before the said Court.

2. Heard the learned counsel appearing for the petitioners and the learned Government Advocate (Crl. Side) appearing for the respondent.

3. The petitioners are arrayed as accused in Crime No.139 of 2013 for the offences punishable under Sections 147, 148, 294(b), 324 and 506(i) of I.P.C., r/w. Section 3(1)(x) of Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Amendment Act, 2015, and that in view of the specific bar under Section 18 of the said



Act, the petitioners cannot move any anticipatory bail application and therefore, the petitioners has come up with this petition.

4. The learned Government Advocate (Crl.Side) would submit that the injured has been discharged from the hospital.

Considering the facts and circumstances of the case, the petitioners are directed to surrender before the Court concerned within ten days from the date of receipt of a copy of this order and file an application for bail.
