Prayer in WP(MD) No.1093 of 2015:

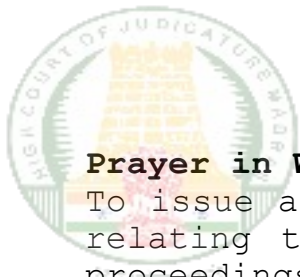
