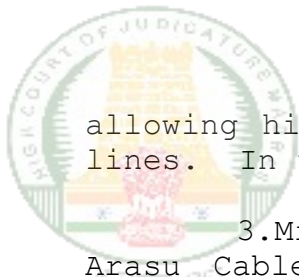

allowing him to take the Arasu Cable TV signals from the existing cable lines. In these circumstances, he has filed the present writ petition.

3.Mr.Abdul Saleem, learned counsel appearing for the Tamil Nadu Arasu Cable TV Corporation submitted that the second respondent will consider the issue and pass orders on merits and in accordance with law.
