2.Heard the learned counsel for the petitioners and perused the materials available on record.

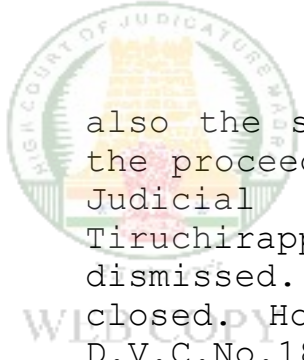
3. D.V.C.No.181 of 2015 was filed against the petitioners under Provisions of Section 12 of Protection of Women from Domestic Violence Act, 2005.

4. Mr.A.Thiruvadikumar, learned counsel for the petitioners would submit that the petitioners have been falsely roped in this case and prays for quashment of the proceedings.

5. Per contra, the learned Government Advocate (Crl. Side), on instructions would submit that the case need not be quashed.
