District Collector, in respect of the issue of shifting of Health Centre to another place and construction of shops in the place therein.

2. Keeping in mind the provisions of the Tamil Nadu Motor Vehicle Rules, as referred to in the Writ Petition, a decision shall be taken, after notice to all concerned, within a maximum period of three months from the date of receipt of a copy of this order.

3. The Writ Petition accordingly stands disposed of. No costs. Consequently, connected Miscellaneous Petitions are closed.
