PRAYER: Writ Petition is filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, directing the respondents to construct the community hall as sanctioned by the Tamil Nadu Government by its order, Na.Ka.No.Sa2/3637/2011-2, dated 30.03.2012 in the proposed site 1877 Sq.metres/46.92 cents in T.S.No.141 in Puliangudi Town in Sivagiri Taluk in Tirunelveli District as passed in the Puliangudi Municipality resolution, vide No.810, dated 11.03.2013 within a time frame.

The petitioner has come up with this Public Interest Litigation seeking a direction to the respondents to construct a Community Hall, as sanctioned by the Tamil Nadu Government, by its order in Na.Ka.No.Sa2/3637/2011-2, dated 30.03.2012, in the proposed site in T.S.No.141 in Puliangudi Town in Sivagiri Taluk, Tirunelveli District.

2. We have heard the learned counsel for the petitioner, the learned Government Advocate appearing for the first and second respondents and the learned Standing Counsel appearing for the third respondent. We have also perused the records carefully.

The learned Government Advocate appearing for the first and second respondents produced a letter from the District Adi Dravidar and Tribal Welfare Officer, in Na.Ka.A2/17899/2013, dated 21.09.2016, wherein he has informed the learned Government Advocate that funds are awaited from the Director and as soon as the funds are made available, the Scheme will be implemented. The said statement is recorded.

4. In view of the same, no further direction is required in this Writ Petition. Accordingly, the Writ Petition is dismissed as infructuous. No costs.
