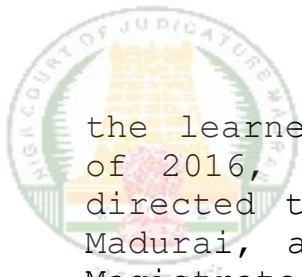
2. Heard the learned counsel for the petitioner and the learned Government Advocate(Crl. Side) for the respondent/State.
