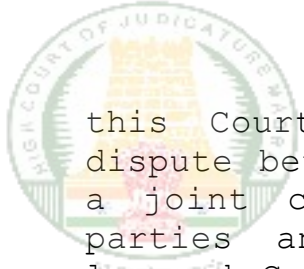
O R D E R

This petition has been filed to call for the records in C.C.No.266 of 2012 on the file of the learned Judicial Magistrate, Eraniel, Kanyakumari District and quash the same.

2. Heard the learned Counsel for the petitioner and the Public Prosecutor appearing for the first respondent.

Based on the complaint given by the second respondent/defacto complainant, a case has been registered against the petitioner in Cr.No.101 of 2012 in C.C.No.266 of 2012 on the file the learned Judicial Magistrate, Eraniel, Kanyakumari District for offences under Sections 341, 294(b), 323 and 506(i) of IPC on the file of the first respondent.

this Court and they categorically made a statement that the dispute between them have been settled amicably.
