The petitioner, who is the old student of E.R.Higher Secondary School, at Trichy, has come up with this petition



complaining that the school authorities are collecting excess fee from the students unauthorisedly. He seeks appropriate direction in this regard.

2. The learned Government Advocate would submit that on these allegations an enquiry was held by the District Educational officer, Trichy and on completing the enquiry, she submitted a report in Na.Ka.No.5386/Aa2/2015 dated 18.09.2015, wherein she has stated that there has been no such illegal collection of any excess fee from the students. The said statement is recorded. However, we are of the view that it is for the competent authority to ensure in future that there is no collection of any excess fee from the students illegally.

3. With the above direction, the petition is disposed of. No costs. Consequently connected Miscellaneous Petition is closed.
