[Order of the Court was made by **The Hon'ble The Chief Justice**]

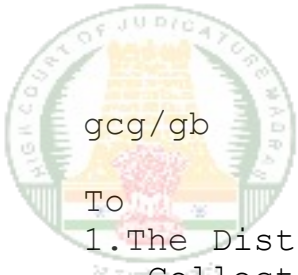
