PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners, who apprehended arrest at the hands of the respondent Police for the alleged offences punishable under Sections 294(b), 323 and 506(i) I.P.C., in Crime No. Not Known of 2016, on the file of the respondent Police, seek anticipatory bail.

2. Heard Mr.G.Karuppasamy Pandian, learned counsel appearing for the petitioners / accused 1 to 3 and Mr.A.P.Balasubramani, learned Government Advocate (Criminal Side) appearing for the State.

3. It is seen that on 18.02.2016 when the matter came up for hearing, it was represented by the learned Government Advocate (Criminal Side) that petition enquiry was pending and hence this Court granted interim anticipatory bail to the petitioners on condition that the first petitioner should report before the respondent Police daily 10.30 a.m., and the petitioners 2 and 3 should report before the respondent Police as and when required for interrogation.

4. Today, when the matter is taken up for hearing, the learned Government Advocate (Criminal Side) has submitted that the complaint lodged by the *de facto* complainant has been closed after conducting enquiry.



5. In view of the submission of the learned Government Advocate (Criminal Side), this criminal original petition is closed.
