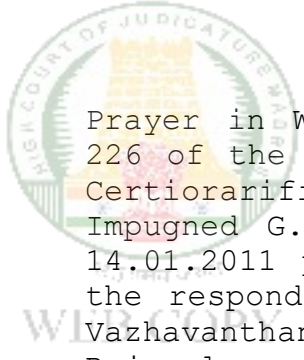

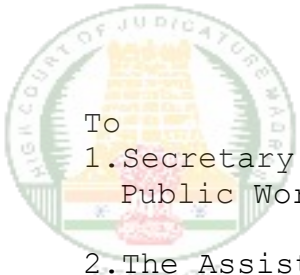
COMMON ORDER
