Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondent.

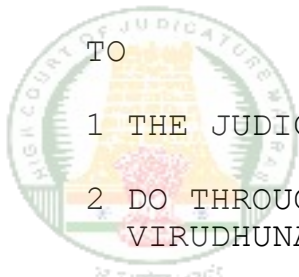
