3. It is seen that on the complaint given by the petitioner, petition enquiry was conducted and closed on 26.03.2016. It is also seen that the suit is pending in O.S.No.180 of 2010, in which interim injunction is ordered, despite which, the opposite parties have entered into sale agreement with certain third parties for the sale of the property and thus, the third parties cut certain trees. However, the respondent police, on the complaint given by the petitioner enquired the case and closed the same and the copy of the closure report has been served to the learned counsel for the petitioner
