The learned Government Advocate (Crl.Side), on instructions would submit that the petitioner is the tenant, after receiving Rs.5,00,000/- (Rupees five lakhs only) from the landlord has vacated the premises. The suit in O.S.No.722 of 2015 was also withdrawn. It is further submitted that the respondents have not insisted the petitioner to vacate the shop, in order to harass him as alleged in the petition.
