ORDER : The Court Made the following order :-

The petitioner is arrayed as A3 and he was arrested and remanded to judicial custody on 02.12.2015 for the alleged offence punishable under Sections 294(b), 302, 449 and 506(ii) IPC, in Crime No.489 of 2015 on the file of the respondent Police and hence, seeks bail.

2.The learned counsel appearing for the petitioner would submit that the petitioner is in custody from 02.12.2015 onwards and a false case has been foisted against him.

3.The learned Government Advocate (Crl. side) would submit that charge sheet has been filed.

4. Considering the facts and circumstances of the case and also considering the fact that the petitioner is in judicial custody from 02.12.2015, this Court is inclined to grant bail to the petitioner with certain conditions. Accordingly, the petitioner is ordered to be released on bail on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate, Sankarankovil, and on further condition that the petitioner shall appear before the respondent police daily at 10.30 a.m until further orders.
