O R D E R

The petitioner has come forward with this petition seeking for a direction, directing the 2nd respondent not to harass the petitioner in Crime No.6 of 2014, on the file of the 2nd respondent police.

2. The main grievance of petitioner is that without any valid reason, the respondent police are harassing the petitioner. The said submission of the petitioner is gainsaid by the Government Advocate (crl.side).

3. The Government Advocate (Crl.side), on instruction, would submit that petition enquiry was conducted and there is no such harassment against the petitioner and if any interrogation or any further investigation is needed by the respondent against the petitioner, the norms which are mentioned in the Judgement of Hon'ble Apex Court in *D.K.Basu Vs. State of West Bengal* reported in AIR (1997) SC 610, would be followed. He would further submit that there will not be any harassment and the enquiry or interrogation would be done in accordance with law.

in future under the guise of any enquiry, the criminal original Petition is closed. The petitioner is directed to co-operate with the enquiry. The petitioner is also directed to co-operate with the enquiry and appear before the respondent police on summons.
